APPLICATION FOR WATERCRAFT REGISTRATION

The following original documents together with copies (or certified copies) of documents to approve registration of Watercrafts are to be handed in with this application.

- Skipper license of each person allowed taking the boat out on the water.
- COF (Certificate of fitness)
- Trailer registration
- Buoyancy certificate.
- Copy of access control disk to The Coves
- **Application fee R 100**

The National Small Vessel Safety Regulations as amended or added to are to be abided by:

- The owner of a vessel must ensure that the vessel is operated by or under the constant guidance of a person (in these regulations called the skipper) who is physically able and of sound mental health and who, in the case of—
- a pleasure vessel that is either a sailing vessel of 6 metres or more in overall length or a power-driven vessel with propulsion power exceeding 15 Horsepower,
- hold a valid certificate of competence issued by a certifying authority: Provided that this provision does not require a certificate of competence to be held in respect of a vessel type which was previously unregulated or is operated on previously unregulated inland waters during the period expiring 12 months after the commencement of these regulations.
- The owner must, in addition to meeting the requirements of the sub-regulation ensure that the vessel is otherwise sufficiently and efficiently manned.

You are required to have the following safety equipment on your watercraft

- Category R - Safety Survey Equipment Checklist (Vessels operating solely on inland waters)
- Lifejackets (SABS 146/1979) Qty is specified on your buoyancy certificate.
- OR Buoyancy Aids (SABS 1417/1987). Qty is specified on your buoyancy certificate.
- Projectile flare set or alternative means of communication
- 500 mm Red Ski flag for pleasure craft.
- Alternative means of communication (if no 29MHZ radio or VHF)
- Fire Extinguishers Service date: specified Qty: as per COF Agents: who serviced them.
- 2 x Oars or paddles (only on vessels with one inboard /outboard engine)
- Capsize Rope (Only on inflatables and ski-boats < 9m length)
- Patent Anchor with chain & min. 50m rope (v/l L > 6m ; 5m chain; v/l L < 6m; 3m chain)
- Drinking water
- First-Aid Kit (suitable for crew compliment)
- Repair kit & air pump or bellows (inflatables)
- Spares & Tools
- Exhaust pipes and silencers water cooled or lagged
- Marking of Equipment, Vessel & Trailer

- Navigation Lights
- Steering Gear (including Emergency Steering)
- Kill switches (outboard engines)
- Towing line of at least 10m (engine < 15HP & non-power-driven L < 7m)
- Bailing device (engine < 15HP & non-power-driven L < 7m)
- Buoyancy Certificate
- Original expired LGSC or COF
- Internal/External Hull condition
