



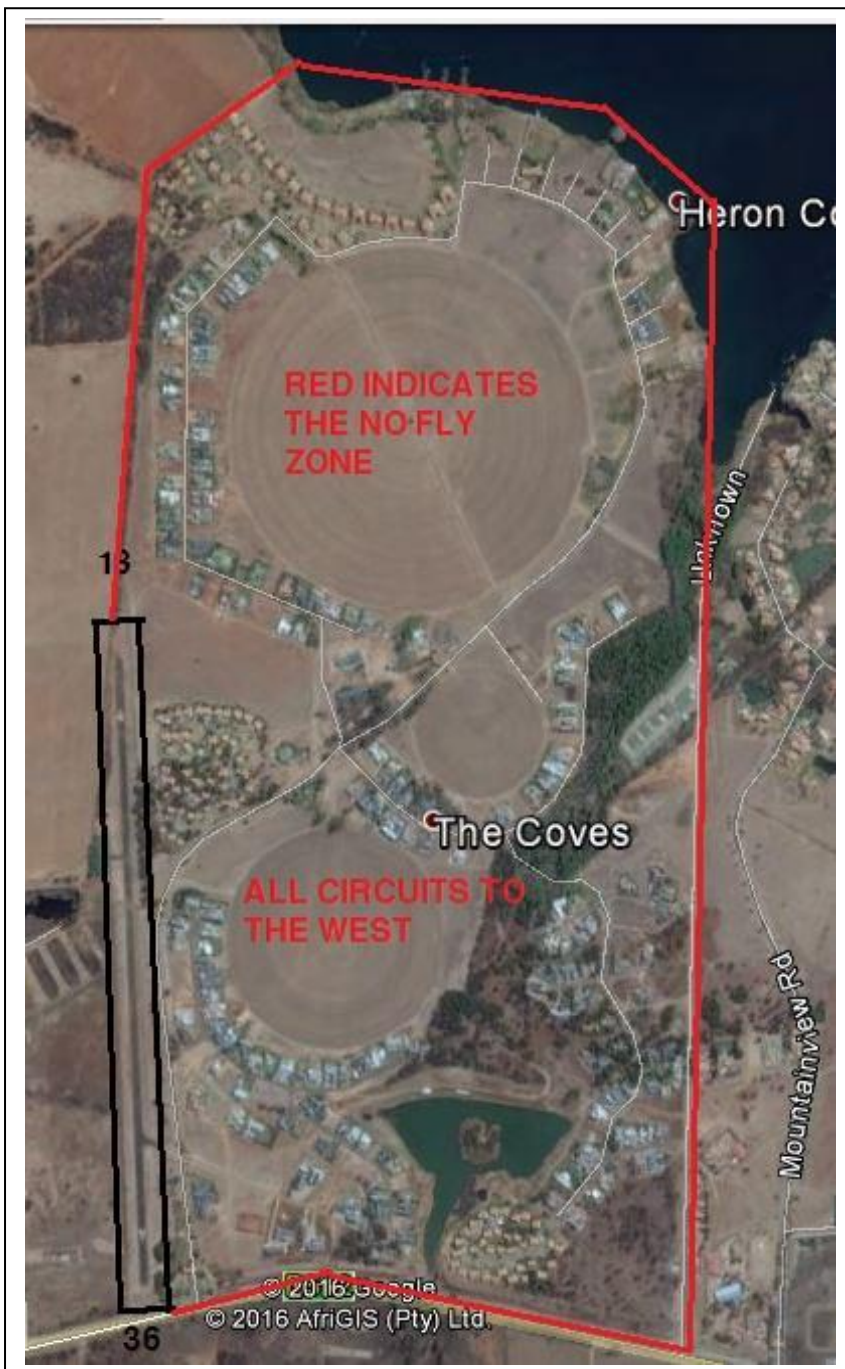

**RUNWAY:** 18/36, 900 m, Tar  
All Circuits to the WEST away from the Estate. Unmanned Procedures Apply.

**NOTES:** Private Airfield in a residential estate. Only for use by residents and their visitors.

Prior Permission Required. No Flying over the Estate.

Noise abatement rules are in force.

Runway 18 is preferred for landing and 36 for take-off.

**CAUTION:** Trees at THR rwy36. Power lines next to the runway. Game and guinea fowl on the runway. Vulture Breeding Colony 3nm NW, keep clear and sharp visuals for soaring vultures at aircraft altitude.

## The Coves Surrounding Airspace Information

Various Airspaces surround the Coves; visitors are requested to familiarise themselves with this busy airspace.

The Coves is under Special Rules West [frequency 125.80], so the Special Rules apply, and the maximum ceiling is 7,500ft. Keep clear of the Lanseria Airspace immediately to the South of the Field.

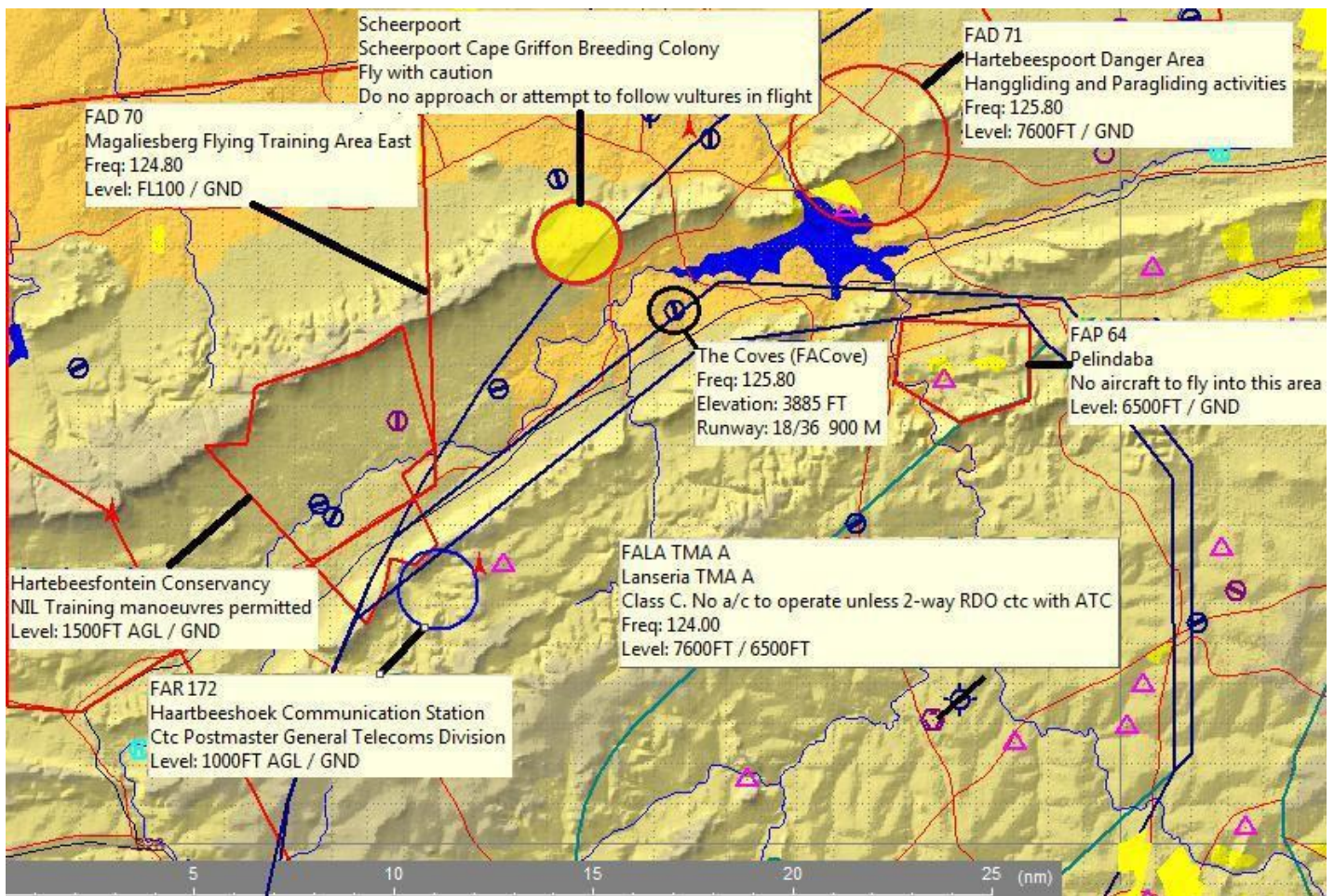
Hartbeespoort Dam is a favourite scenic fly-out destination for all kinds of aircraft in the Gauteng Area. It can get very busy. Keep a lookout for hot air balloons, paragliding and hang gliding, trikes, power parachutes, helicopters, military aircraft, regular aeroplanes, and Vultures.

3NM Northwest of the Coves on the ridge is a Cape Griffon/Vulture Breeding Colony; please keep clear. Also, keep a sharp lookout for vultures soaring up and down the valley, typically at aircraft altitudes of 5,000-7,500 ft.

Take notice of the Hartbeesfontein Conservancy 6NM Southwest in the valley—no flying below 1,500 ft AGL over this protected area.

We recommend that all training manoeuvres be conducted to the Northwest across the ridge in FAD70 – (The Magaliesberg Flying Training Aero East). This area is only 6NM (2 mins) away from The Coves, so it is very close and has a generous ceiling of 10,000 ft.

**EXTRACT of applicable AIRFIELD AND AIRCRAFT Rules has been taken up in The Coves General Rule Book**

- 2.1 The reduction of noise, especially in this country's environment, is an important criterion for all.
- 2.2 No activity or even hobby, which causes aggravation or nuisance to owners, may be conducted at the Coves.
- 6.1 The airfield is for the sole use of the residents of The Coves and their invited visitors. All visitors will be required to complete the Aviation Visitor Information Registration Indemnity form before landing.
- 6.2 Consideration for other owners must be given at all times when using the airfield.
- 6.3 Engine runs should be done with consideration for other residents.
- 6.4 Flying will only be permitted during civil daylight hours. Officially, this is from 15 minutes before sunrise to 15 minutes after sunset. Except on Sundays, no take-offs will be allowed before seven o'clock in the morning.
- 6.5 All aircraft are to join to the west of The Coves airfield at 5300 ft. and fly the circuit to the west of the field. The frequency in use is 125.80 and call The Coves.
- 6.6 No high-speed flypasts along the runway will be allowed at any time. Runway inspections for rogue animals on the runway should be done with caution, preferably along the western boundary, but if necessary, down the runway only.
- 6.7 Helicopters and Gyrocopters are to follow the same procedures as above.
- 6.8 The preferred runway for take-off is 36, and the preferred runway for landing is 18.
- 6.9 No flying is allowed over the Coves.
- 6.10 No vehicles other than aircraft and vehicles belonging to airfield users are permitted in the airfield area.
- 6.11 No jogging, biking or walking is allowed within the airfield boundaries.
- 6.12 Aircraft should be parked in an orderly manner in the designated areas at the owner's full discretion, as far as possible from the runway.
- 6.13 Any person using or entering the airfield area undertakes not to make any claim against and indemnifies and holds harmless the governing bodies, their directors, their officers, servants or agents against any claims, costs or expenses whatsoever arising from the materialising in any manner whatever of any of the risks aforementioned.

**Please fly in the vicinity of The Coves, as if it were a Controlled airspace:  
(Excellent Airmanship, Proper Circuits, No Aerobatics, No Low Level, No Show-offs, No Flight over the Estate).  
Limit noise at all times and clear the area ASAP after take-off.**
